- The entire Works under the Contract shall have to be completed in all respects within **12 months** from the date of issue of letter of award.
- The EMD can be submitted in the form of Bank Demand Draft/BG/FDR/CDR in favour of MD, PTCUL payable at Dehradun from any Scheduled Bank /nationalized Bank.

#### A. Pre Qualifying Criteria

## I. Technical Qualifying Requirement

#### 1.0 Qualification of Bidder

Qualification of bidder will be based on meeting the minimum pass/fail criteria specified below regarding the Bidder's Technical Experience as demonstrated by the Bidder's responses in the corresponding Bid Schedules.

The bid can be submitted by:-

- (i) Bidder shall be a Qualified Manufacturer meeting the specified requirements given under para 1.1 & 1.2, or
- (ii) Qualified Licensee of a Qualified Manufacturer (Requirements specific to Licensor-Licensee route are given under Para 1.1 (c) & 1.3 below), or
- (iii) A Joint Venture of two firms (Requirements specific to Joint Ventures are as per Standard bidding document & para given under 1.1(c).

## 1.1 Technical Experience:

(a) The Qualified Manufacturer shall be an Indian manufacturer of HTLS conductor for the last five years.

The Qualified Manufacturer should have manufactured, type tested and supplied at least **47 KM** of High Temperature Low Sag (HTLS) conductor (except GAP conductor) of same technology as that of the conductor being offered in this package having minimum thirty (30) number of strands or 100 sq. mm. aluminum cross section area having at least same or more number of strands as that of the conductor being offered in last ten(10) years as on originally

scheduled date of bid opening, and the same should have been in satisfactory operations\* for a period of at least two (2) years as on the scheduled date of bid opening mentioned above in India.

OR

(b) An indigenous manufacturer not meeting the requirement stipulated in clause 1.1(a) above can also participate provided he meets the following requirements as on schedule date of bid opening mentioned above:

The indigenous conductor manufacturer must be a manufacturer of conductor for the last five years.

The indigenous conductor manufacturer must have manufactured, tested, supplied at least 23.5 KM of High temperature low sag (HTLS) conductor (except GAP conductor) of same technology as that of the conductor being offered in this package having minimum thirty (30) number of strands or 100 sq. mm. aluminum cross section area having at least same or more number of strands as that of the conductor being offered in last ten (10) years as on originally scheduled date of bid opening as mentioned above and the same should have been in satisfactory operations\* for a period of at least one (1) year as on the scheduled date of bid opening mentioned above in India.

Note: In case of clause 1.1(B) above, the warranty obligations for additional period of two (2) years over and above the warranty period as specified in the bidding documents shall be applicable.

\* Satisfactory operation means Certificate issued by the Employer certifying the operation without any adverse remark.

<u>OR</u>

- (c) Indigenous conductor manufacturer not meeting the qualification requirements stipulated at para 1.1(a) & 1.1(b) above can submit bid as:-
  - (i) A Qualified Licensee of a Qualified Manufacturer (Licensor) meeting the requirement stipulated at para 1.1(a) (Requirements specific to Licensor-Licensee route are given under Para 1.3 below), or
  - (ii) A Joint Venture of two firms (Requirements specific to Joint Ventures are as per Standard bidding document).

## provided that:-

The Indigenous conductor manufacturer is a manufacturer of conductor for the last five years & has manufactured, tested and supplied at least one thousand (1000) km of ACSR/ AAAC/ ACAR/ AACSR conductor having at least same or more number of strands as that of the conductor being offered in the package during last five (5) years as on the date of bid opening mentioned above.

Note: In case of Clause 1.1(c) above, indigenous conductor manufacturers participating as a Qualified Licensee or as a partner in JV with Qualified manufacturer shall provide warranty obligations for additional period of two (2) years over and above the warranty period as specified in the bidding documents shall be applicable.

#### 1.2 Erection Criteria for bidder as Manufacturer:-

- a) The bidder should have completed stringing of High Temperature Low Sag (HTLS) conductor (except GAP conductor) of not less than <u>47 KM</u> route length of 132 KV or higher voltage class transmission line in a single project as a prime contractor in India with in the last five (5) years and the line should be in satisfactory operation for minimum one (01) year as on the scheduled date of bid opening.
- b) The bidder should have the certified master installer of HTLS conductor from the licensor & have to furnish relevant documents at the time of bid.

#### 1.3 Requirements specific to Licensor-Licensee route:-

In case of bid by an Indigenous conductor manufacturer as a Qualified Licensee of a Qualified Manufacturer (Licensor) meeting the qualification requirements set forth in para 1.1(A), the Licensee should meet the following conditions:

- i) Qualified Licensee shall have adequate design infrastructure and manufacturing facility and capacity and procedures including quality control.
- ii) A Qualified Licensee of a Qualified Manufacturer shall comply with all of the following requirements and furnish a joint undertaking by the licensor along with the bidder in its bid.
- a) Any design undertaken by the Licensee shall be approved by the Licensor.
- b) Manufacturing by the Licensee shall be done with the approval of the Licensor under a quality assurance programme approved and monitored by the Licensor.
- c) In addition to the Contract Performance Security to be furnished by the bidder, the Licensor shall furnish back up performance security in the form of bank guarantee for 5 % of the CIF/ Ex-works cost of the HTLS conductor as per format provided in the bid documents for successful performance of HTLS conductor to be manufactured and supplied by the Licensee under the contract.
- d) Licensor must guarantee sequential and timely supply of materials and submission of technical information and data as desired by the Employer so as to meet the overall construction schedule and
- e) The agreement between Licensee and Licensor (copy to be submitted along with the bid) shall be valid for a period of at least five (5) years after the guarantee period of equipment and materials under supply is over.

In case bidder is a holding company, the technical experience referred to in clause 1.1 above shall be of that holding company only (i.e. excluding its subsidiary/group companies). In case bidder is a subsidiary of a holding company, the technical experience referred to in clause 1.1 above shall be of that subsidiary company only (i.e. excluding its holding companies).

## 1.3 The bidder shall submit documentary evidence in support of qualification requirement stipulated above.

The warranty obligations for bidder for additional period over and above the warranty period as specified in Clause 1.1 (A), 1.1(B), 1.1 (C) and 1.1(D) are to be included in the bidding documents.

**1.4** The bidder must comply the GTP of various items along with vendor name for supply of items in case of bought out items from the approved vendor in PGCIL/PTCUL and an undertaking to this effect must be submitted with the bid. All items should be type tested during last five (5) years.

## 2.0. Financial Qualifying Requirement

- 1. <u>Minimum Average Annual Turnover:</u> The minimum average annual turnover of the tenderer for the best three years (36 months) out of the last five years should not be less than Rs. 16.39 Crores.
- 2. <u>Access to Finances:</u>— The Bidder must demonstrate availability of access to finance for **Rs. 3.28 Crore** at the time of bidding through a certificate (as per Annexure-A) duly certified by a Chartered Accountants/ Auditor of the company which shall not be more than one month old as compared as compared to the date of submission of the bid.

For Financial Qualification Criteria, lead partner of JV Firms should meet minimum 50% of Financial Qualification Requirement (FQR) and collectively meet total Financial Qualification Requirement of the respective tender. All partners of JV Firms should have the experience for activities of Construction/Manufacturing of items or equipments/Supply of items or equipments or products, meant for transmission utilities only.

- 3. Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:
- (a) Three similar completed works costing not less than the amount equal to Rs. 4.37 Crore.

(b) Two similar completed works costing not less than the amount equal to Rs. 5.46 crore.

OR

- (c) One similar completed works costing not less than the amount equal to Rs. 8.74 Crore.
- **B.** E.P.F. Registration certificate is mandatory to be submitted with the technical bid (part-I).
