TENDER NOTICE

Tender Title: Assistance in carrying out miscellaneous routine works for preventive maintenance of different transmission lines under 132KV Substations, Almora and 132KV Substation, Ranikhet.

Sealed and separate tenders in two parts (Part-I & II) are invited for the work of “**Assistance in carrying out miscellaneous routine works for preventive maintenance of different transmission lines under 132KV Substations, Almora and 132KV Substation, Ranikhet**” against **Tender Specification No. SE(O&M)/PTCUL/HLD/03/2019-20** from qualified, capable and experienced contractor/firm who has successfully completed/carried of electrical maintenance of substations/transmission lines of 132 KV or above preferably in PTCUL/PGCIL/NTPC. The contractor/firm who has adequate professional knowledge, expertise and practical experience and also have adequate availability of skilled manpower suitable and trained for such electrical maintenance works under standard safety conditions/measures.

The tender documents shall be downloaded from PTCUL’s official website www.ptcul.org. The details regarding the downloading and submission of bid/tender documents are as follows;

PART- I (TECHNO-COMMERCIAL BID)

Part-I of the bid shall essentially contain the following documents-

Cost of Tender Documents	Rs. 1000.00 + GST @ 18% = Rs. 1180.00 (Rs. One Thousand One Hundred Eighty Only) The cost of tender document, as mentioned above, shall be paid in shape of Demand Draft only of any Scheduled/Nationalized Bank and shall be in favour of Executive Engineer, Operation & Maintenance Division, PTCUL, Almora payable at Almora . Tender fee is non-refundable.
Earnest Money/EMD	Rs. 42,000.00 (Rs. Forty Two Thousand Only) The EMD, as mentioned above, can be submitted only in the form of DD/FDR/CDR of any Scheduled Bank/Nationalized Bank only and shall be pledged in favour of Executive Engineer, Operation & Maintenance Division, PTCUL, Almora payable at Almora .
Technical Qualifying Requirements (TQR)	(a) The bidder must have successfully completed the similar nature of work of electrical maintenance of substations/transmission lines of 132 KV or above preferably in PTCUL/PGCIL/NTPC satisfactorily. Submission of work completion certificate is mandatory for supporting the claim of work experience. The above work should have been completed within last seven year as on the original scheduled date of bid opening. (b) The bidder must have experience of carrying out annual maintenance contracts with adequate manpower (not less than 16 nos. of labourers for duration of at least 6 months in continuation) at his disposal, engaged in similar work activities during last seven years. The bidder is required to submit documentary proof i.e. payments/PF contribution to claim such qualification. (c) Experience of having successfully completed similar works preferably in PTCUL/PGCIL/NTPC during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:

	<p>Three similar completed works costing not less than the amount equal to Rs. 4.70 Lakhs.</p> <p style="text-align: center;">OR</p> <p>Two similar completed works costing not less than the amount equal to Rs. 5.87 Lakhs.</p> <p style="text-align: center;">OR</p> <p>One similar completed works costing not less than the amount equal to Rs. 9.40 Lakhs.</p> <p>In the above criteria, the “Similar Work” shall be “electrical maintenance works of substations/transmission lines of 132 KV or above preferably in PTCUL/PGCIL/NTPC”.</p>
Financial Qualifying Requirement (FQR)	<p>(a) Minimum Average Annual Turnover: The minimum average annual turnover of the tenderers for the best three years (36 months) out of the last five years (60 months) should not be less than Rs. 20.80 Lakhs (Rupees Twenty Lakhs Eighty Thousand Only)</p> <p>(b) Access to Finances: The bidder must demonstrate availability of access to finance for Rs. 8.32 Lakhs (Rupees Eight Lakhs Thirty Two Thousand Only) at the time of bidding through a certificate (as per annexure-A) duly certified by a chartered accountant/auditor of the company which shall not be more than one month old on the date of submission of the bid.</p> <p>(c) For Financial Qualification Criteria, lead partner of JV Firms should meet minimum 50% of Financial Qualification Requirement (FQR) and collectively meet total Financial Qualification Requirement of the respective tender. Lead partner of JV Firms should have the experience of electrical maintenance of substations/transmission lines of 132 KV or above preferably in PTCUL/PGCIL/NTPC.</p> <p>(d) Registration in GST, EPF, ESI & ‘A’ Class Electrical Licence is mandatory and the relevant certificates are to be submitted with the Technical Bid (Part-I).</p> <p>(e) Latest Bank solvency certificate of 20% of the tender value is required to be furnished by the tenderer along with the Technical Bid (Part-I).</p>

PART- II (PRICE BID)

Part – II shall essentially contain the following documents-

Tender Forms	Duly filled, signed and stamped tender forms, as uploaded by the PTCUL, elaborating all the information required. Self-attested and stamped copies of supporting documents should be enclosed wherever necessary.
Price Bid	The bidder has to quote their prices strictly in ‘ Price Bid/BOQ Format ’ only as given on tender documents. Validity of bid price shall be at least 180 days. The undertaking should be furnished in requisite format as per tender documents.

GENERAL INFORMATION

1. The bidder can freely view and also download the tender documents from the website **www.ptcul.org**.
2. The tender fee, as mentioned above, shall be paid in shape of Demand Draft only of any Scheduled/Nationalized Bank and shall be in favour of **Executive Engineer, Operation & Maintenance Division, PTCUL, Almora**. Tender fee is non-refundable.
3. The EMD can be submitted only in the form of DD/FDR/CDR of any Scheduled Bank /Nationalized Bank only and shall be pledged in favour of **Executive Engineer, Operation & Maintenance Division, PTCUL, Almora**.
4. The bidder has to quote their prices in '**Price Bid/BOQ Format**' only as given on tender documents.
5. In case of incomplete/incorrect documents are submitted in Bid Part-I by the bidder/bidders or the bidder/bidders do not qualify the TQR/FQR, the Part-II of the respective bidder/bidders shall not be opened.
6. The submission of bids documents should only be through registered post or speed post. Bids documents delivered through any other means shall not be accepted. This office shall not be responsible for any delay in transit of bid documents or if it is not made available by the Postal Department at the prescribed address.
7. Tender bids shall be received and opened on the date as mentioned above or any extension thereof. In case the above date is declared a holiday, the tenders will be received & opened on the next working day.
8. It is mandatory for the bidder to submit the hard copy of Schedule-C (Bid validity declaration) and 'Declaration' regarding correctness of the documents, in Rs.100 stamp duly notarized, as per the format given in the tender documents.
9. The bidder should submit the relevant certificate claiming registration in GST, EPF, ESI & 'A' Class Electrical License along with bid documents.
10. In case a bid is submitted by a bidder as a Joint Venture (JV) firm then such joint venture will be allowed for a maximum of two firms only where one will be the lead partner and the other firm will be treated as JV partner. One of the partners shall be nominated as lead Partner, and this authorization shall be evidenced by submitting a Power of Attorney signed by legally authorized signatories of all the partners. The Lead Partner shall be authorized to incur liabilities and receive instructions for and on behalf of any partners of the Joint Venture, and the entire execution of the Contract, including payment, shall be done exclusively with the Lead Partner. All partners of the Joint Venture shall be liable jointly and severally for the execution of the Contract in accordance with the contract terms, and a statement to this effect shall be included in the authorization mentioned above as well as in the Bid Form and in the Contract Form (in case of a successful Bid). Agreement entered into by the joint venture partners shall be submitted with the bid and will remain in force during the tenancy of contract and Guarantee Period thereafter. The lead partner of the Joint Venture firm should meet 100% of the technical qualifying requirement (TQR) of the respective tender.
11. Bidders are advised to participate in Pre Bid meeting for any clarifications required.
12. The bidders are requested to read all the instructions/conditions of the bid documents and submit their bid accordingly. Be insured that all the required and supporting documents have been enclosed with the bid documents.
13. The tenderer reserves the right to reject one or all tenders without assigning any reason thereof.
