## **INSTRUCTIONS TO BIDDERS AND GENERAL CONDITIONS OF CONTRACT**

### **INTRODUCTION**

#### 1.0 GENERAL PARTICULARS:

1.0 The Power Transmission Corporation of Uttarakhand Ltd. Dehradun herein after called "PTCUL/OWNER" (the term would include PTCUL) intends to receive "PROVIDING AND FIXING OF FALSE CEILING AT CONTROL ROOM OF 220KV SUBSTATION UNDER 220KV OPERATION AND MAINTENANCE DIVISION RISHIKESH" through Superintending Engineer,400KV(O&M) Circle, Rishikesh as detailed in the accompanying specification in accordance with the terms & conditions herein. The bids shall be prepared and furnished as per these instructions.

#### 2.0 <u>REQUIREMENTS:</u>

#### A: PRE-QUALIFYING REQUIREMENTS:

- 2.1 : <u>Tender Cost:</u> Tender document cost Rs. 500.00 plus 18.00 % GST i.e. Rs. 590.00 (Non-refundable) shall have to be deposited by the Tenderer in the shape of Demand Draft only in favour of Executive Engineer, 400KV O&M, Division Rishikesh on any scheduled bank payable at Rishikesh.
- 2.2: <u>EARNEST MONEY(EMD)</u>: Earnest Money amounting to Rs. 25,000.00 (Rs. Twenty Five Thousand only) in the shape of CDR/FDR/TDR/BG duly pledged to **Executive Engineer**, 400KV O&M, Division Rishikesh should be valid min. for "ONE YEAR".
- **2.3:** Micro and Small Enterprises (MSEs) as defined in MSE Procurement Policy issued by department of Micro, Small and Medium Enterprises (MSME) are exempt from submission of EMD (Bid Security).
- 2.4: MSEs having Udyog Aadhaar Memorandum (UAM) certificate will be provided tender sets free of cost. However bidders are required to submit valid UAM certificate and their claim for free tender cost will be considered for the service/category for which they are registered as per UAM certificate.

#### **B.<u>TECHNICAL CRITERIA</u>**

2.5 The Tenderers should have submitted "Bid submission confirmation".

The Tenderer/bidders should have adequate experience of similar type of work during last Seven years, as per following conditions:

Three similar completed works costing not less than amount equal Rs. 3.36 Lac each.

Or

Two similar completed works costing not less than amount equal Rs. 4.20 Lac each.

Or

One similar completed work costing not less than amount equal Rs. 6.72 Lac each.

- 2.6 The experience must be from Government Departments/ Utility/PSU's.
- 2.7 Bidder should have submitted the experience certificate of past works issued by an officer not below the rank of Executive Engineer.

### C. <u>FINANCIAL CRITERIA</u>

- 2.8 Agreement of validity of duly executed on non-judicial stamp paper worth Rs. 100.00 duly affixed with Rs. 1.00 Revenue stamp should be submitted.
- 2.9 Copy PAN Card of Individual/Company/Firm/All partners in case of partnership firm should be attached.
- 2.10 Tenderer should have submitted copy of GST Registration.

- 2.11 The Employee Provident Fund (EPF) Registration Number shall be a mandatory PQR for award of Work Contracts, Manpower Contracts, Vehicle Hiring Contracts and Annual Maintenance Contracts etc. along with latest proof for submission of EPF of employees in EPF department.
- 2.12 RTGS/NEFT Details of the bidder is to be submitted.
- 2.13 Solvency certificate from Bank (20% of bid value) should be submitted.
- 2.14 Minimum Average Annual Turnover (MAAT) should be Rs. **12.60** Lac for the preceding best three years out of the last five financial years.

Note: The Balance sheet and other financial documents attested/ certified by CAs to substantiate fulfillment of FQR should be with UDIN failing which the tender will be summarily rejected without any further reference.
