- 3. # **PART B**

#### **PRE-QUALIFYING CRITERIA**

## (A) Technical Qualifying Requirement

- 1. The Bidder must be Experienced Contractors of having sufficient experience of vehicles or individual owner of vehicles and necessary proof to this effect be enclosed in part lst.
- 2. If contractor hired the vehicles he shall submit the hired agreement between owner and contract or affidavit for hiring of vehicles with period of 1 and ½ year from the date of opening of tender.

## (B) Financial Qualifying Requirement

- 1. **Minimum Average Annual Turnover:**The minimum average annual turnover of the tenderer for the best three years (36 months) out of the last five years, audited accounts should not be less than Rs. 6.37 Lac.
- 2. Access to Finances: The bidder must demonstrate availability of access to finance for Rs. 1.27 (Rs. One Lakhs Twenty Seven Thousand Only) at the time of bidding through a certificate (as per annexure-A) duly certified by a chartered accountant /auditor of the company which shall not be more than one month old on the date of submission of the bid.
- 3. For Financial Qualification Criteria, lead partner of JV Firms should meet minimum 50% of Financial Qualification Requirement (FQR) and collectively meet total Financial Qualification Requirement of the respective tender.
- 4. Experience of having successfully completed similar works during last seven years ending last day of month previous to the one in which applications are invited should be either of the following:

Three similar completed works costing not less than the amount equal to Rs. 1.70 Lakhs.

OR

Two similar completed works costing not less than the amount equal to Rs. 2.12 Lakhs.

OR

One similar completed works costing not less than the amount equal to Rs. 3.40 Lakhs.

In the above criteria, the "Similar Work" shall be "vehicle hiring.

- C. Registration in PAN.GST, EPF, is mandatory and the relevant certificates are to be submitted with the Technical Bid (Part-I).
- D. The balance sheet and other financial documents attested/certified by CAs to substantiate fulfillment of FQR should be with UDIN (Unique Document Indentification Number) failing which the tender will be summarily rejected without any further reference
- E. The bidder shall not have any litigation pending with PTCUL. If any litigation is pending with PTCUL the bid shall not be consider.
- F. Bid validity: 180days
- G. Completion Period: 365 days
- H. Commercial docuemts for vehicles which shall be hired (RC,Insurance,Fitness, permit, Pollution cetrtificate and other authentic documents)
- I. The Service provider should not have been black listed as on the last date of proposal.
