

2. The Vendor Registration will be applicable only if company qualifies the techno-commercial conditions of the respective tender.
3. The equipment/material to be supplied should be type tested for it's design as per requirement of agreement.
4. Drawing and GTP to be approved by Engineering wing of PTCUL at the initial stage as per the terms & conditions of respective contract.
5. Company has to get the approval of MQP & FAT from QA/QC before commencement of their production.
