

4. Drawing and GTP to be approved by Engineering wing of PTCUL at the initial stage as per the terms & conditions of respective contract.
5. Company has to get the approval of MQP & FAT from QA/QC before commencement of their production.

6. This acceptance does not absolve the Company from contractual obligations & terms and conditions of the respective tender.
7. Validity of approval shall be considered based on timely supply & quality performance.
