

Your Vendor Registration has been accepted with following conditions:-

1. Company will have to follow the rules and regulations laid down by PTCUL.
2. The Vendor Registration will be applicable only if company qualifies the techno-commercial conditions of the respective tender.
3. The Power Transformer & Reactor to be supplied should be type tested for it's design as per requirement of agreement.
4. Drawing and GTP to be approved by Engineering Wing of PTCUL at the initial stage as per the terms & conditions of respective contract.
5. Company has to get the approval of MQP & FAT from QA/QC before commencement of their production.

7. Validity of approval shall be considered based on timely supply & quality performance.
