## **PART B**

### **1.0 Pre Qualifying Criteria for the Contractor**

#### **1.1 Technical Criteria**

- i. The Bidder/ Collaborator/JV Partner must have executed similar works i.e. he must have constructed either a 220 D/C line of minimum 6.00 Km or a 220 KV S/C line of minimum 12.00 Km on turnkey basis in the last three years and these works should be working satisfactorily.
- ii. The bidder must comply the GTP of various items along with vendor name for supply of items in case of bought out items. All items should be type tested during last five years.
- iii. It is binding to the bidders to submit all the supporting documents at the time of bid.

#### **1.2 Financial Criteria**

The annual average turnover of the Tenderer for the preceding three years should not be less than **Rs 06.99 crores**.

However, for Consortium/Joint Venture Company (JVC), qualifying financial criteria of total turnover is permitted for the firms, who are already in transmission activities of construction, manufacturing items, equipments or products meant for transmission utilities and one of JVC/Consortium member shall qualify required technical qualification.

**Access to finances** – the Bidder must demonstrate access to, or availability of, financial resources such as liquid assets, unencumbered real assets, lines of credit, and other financial means, other than any contractual advance payments to meet the following cash flow requirements- **Rs. 13.99 crores** supported by documents in form “access to credit facilities”.

The other details, terms & conditions are given in tender documents.


