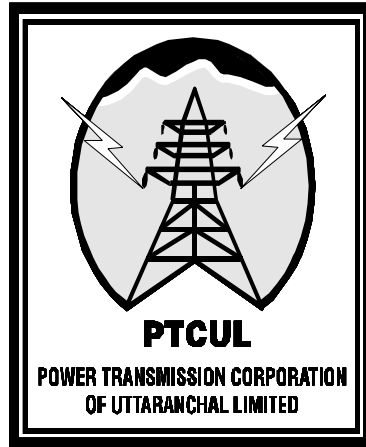

SPECIAL TERMS & CONDITIONS OF THE CONTRACT

1. The vehicle shall be used strictly and exclusively as per instructions of EE, O&M Div. Srinagar. The vehicle will be used for a maximum of 2000 to 3000 Km. per month normally.
2. The vehicle to be provided must be Diesel Fueled jeep having average not less than 10 Km/Ltr. On hills and 12 Km/Ltr. In plain area.
3. The Vehicle should carry valid Insurance for the entire period.
4. The Vehicle should be in good condition.
5. The Vehicle should have valid Taxi Road permit of whole Uttarakhand, UP and Delhi State.
6. The license of Driver should be valid for both Hilly area and plain area.
7. The Department will be paid only hiring charges of the jeep on Pro. Rate basis. Nothing beyond hiring charges will be paid to contractor except Diesel as fuel.
8. The Vehicle should have a seating capacity of not less than 5 persons as specified and designed by the manufacturer.
9. The Salary/claims of the driver shall be entire responsibility of the contractor, valid driving License of the Driver must be shown whenever required.
10. Only the cost of the fuel (Diesel) will be borne by the department. The fuel consumption and Mileage of the vehicle to be provided shall be as per manufacturing/standards norms as mentioned above.
11. All expenditure towards cost of maintenance and repair of vehicle, road taxes and insurance shall be paid by the contractor well in time. In case of breakdown of vehicle another vehicle shall be provided by the contractor with out any extra cost with in 6 hours. In case of delay beyond 6 hours the charges for such delay penalty will be deducted from the bill of the Contractor @ Rs. 600.00 per day or its part for such no. days, in as month for which the Vehicle is not made available by the contractor.
12. The availability of vehicle is to be for 24 hours under EE, O&M Div. Srinagar for Which no extra amount will be paid.
13. The fixed charges of the vehicle will be payable on monthly basis, the contractor shall produce the pre-receipt bill for every month to Ex. Engineer, O&M Division Srinagar., in triplicate and the payment of the same shall be made with in 30 days from the date of receipt of the bill subject to the availability of fund.
14. The logbook will be maintained by the EE, O&M Division, Srinagar.
15. In case of any accident of damage with the vehicle, the entire responsibility shall be part of the contractor. Any official/Officer of the department will not be liable to compensate any damage what so ever in the event of litigation etc
16. In on account of strike or if vehicle in note made available deduction as per point 11 above shall be made from monthly bill.
17. Earnest money deposited in the tender shall be retained as security and shall be refunded after completion of the Agreement.
18. The Engineer of the contract reserves the right to reject any or all the offers without assigning any reason thereof.
19. Income Tax as per rule shall be deducted from the bill.
20. The Vehicle is required for a maximum period of 1 year and the period can be extended/withdrew with notice of 30 days by PTCUL.
21. Normally the vehicle shall be used maximum 8-10 hrs. in a day.
22. In case of any dispute, the decision of Executive Engineer, PTCUL. Srinagar shall be final and binding to both.
23. All general conditions of Form "A" & "B" of PTCUL shall be applicable.
24. The contractor shall provide well trained driver for duty. The driver shall be well behaved and must be dressed in the uniform prescribed by the corporation. The driver shall have valid driving license. The duty hours of a driver for vehicle on monthly basis shall usually be from 9:00 AM to 9:00 PM. The timings may differ occasionally depending upon the requirements In the event of driver not able to perform his duty properly; the contractor shall have to replace him with another one.
25. The contractor shall provide mobile phone to the driver for which no extra claim shall be admissible. The mobile phone shall have to be kept on round the clock.
26. The vehicle hired on monthly basis shall be packed at a place decided by the officers in charge. The contractor has to make necessary arrangement for the driver to reach the duty in time. Drivers shall not be allowed to take the vehicle with them at the close of duty.
27. The vehicle are hired for local is well as out stations duties. The contractor shall have to pay the driver for out station halts at the rate of Rs.100.00 per night in case of a place in Uttarakhand & UP and @ Rs.200.00 per night in case of Delhi. The charges shall be reimbursed to the contractor on actual basis on production documentary proof.
28. The contractor shall ensure that the wages for drivers is not paid less than minimum wage as specially by the labour commissioner.
29. Rate quoted shall include all legal taxes such as sales tax, local taxes, royalty, S.T and octroi etc. as applicable, no. extra payment shall me made on this account. The rates shall remain firm during the currency of contractor period.
