<b>(B) Part-II:- Part-II of the tender shall contain the TQR &amp; FR.</b>		
(i).	F.R. Average Annual turnover	The minimum average annual turnover of the contractor shall not be less than <b>Rs.42.00 Lacs/-</b> during past three financial years. The following documents must be submitted in support : <b>a) If audit for the contractor/firm is compulsory and audited accounts are available-</b> the contractor must submit Audited Accounts( P/L accounts, balance sheets etc). <b>b) If audit for the contractor/firm is not compulsory</b> and audited accounts are not <b>available:</b> The contractor must submit certificate of turn-over from Chartered Accountant (C.A.). A provisional account must also be submitted. In addition, it shall be mandatory for contractor to submit a certificate from same C.A. clearly certifying the fact that <u>“Accounts are not required to be audited under statute”</u> .
(ii)	Liquid Assets	Liquid Assets of the bidder should not be less than <b>Rs. 26.00</b> lacs at the time of bidding.
(iii)	Income Tax Clearance :	A copy of PAN of the firm and all its partners (duly attested).
(iv)	Trade Tax Registration:	A copy of trade Tax Registration (duly attested).
(v)	EPF Registration :	A copy of EPF Registration (duly attested), if applicable
(vi)	TQR.	The tenderer should have adequate experience of having completed at least one contract of civil work costing not less than <b>Rs.68.00 Lacs/-</b> in any one year during last three years. Experience certificate should be issued by an officer not below the rank of Executive Engineer, mentioning name of work, agreement no., amount of work done, schedule time of completion versus actual time of completion, quality of work done, performance etc.
<b>(C) Part-III:- Part-III of the tender shall contain only the price Bid.</b>
