Tenders shall be received through Registered/Speed Post only (acknowledgement due) addressed to Superintending Engineer, Operation & Maintenance Circle, PTCUL, 220KV Substation Campus, Kamaluaganja, Haldwani in the office upto 17:00 PM on specified date. The department shall not own any responsibility regarding the postal delay in the receipt of the tender.

The Part-II of the tenders, belonging to only those tenders who qualify for the work on the basis of the documents supplied by them in Part-I, shall be opened publicly same day. All other terms and conditions shall be as per tender documents.
