(A) **Part-I** : Part-I of the tender shall contain the following :

- iii) Technical Qualification :
 - 1- The tenderer must have adequate experience of electrical/similar nature of work for following work.
 - 2- The bidder should have successfully completed a single contract, involving electrical works/ Similar nature of work for a value not less than Rs. 5,04,756.00(Inclusive GST) during last Five financial years from the date of publication.
 - 3- Past experience inter-alia document establishing the execution of similar work successfully, photocopy of awarded works, schedule time of completion and actual time of completion, the present status of project in hand along with presently envisaged completion dates, qualification and experience of key personnel proposed for carrying out the subject work.
- iv) Financial Qualification : For the purpose of this particular bid, bidders shall meet the following minimum criteria:-
 - 1- Minimum average annual turnover (MAAT) for the best three financial years, out of last five financial years of the bidder should not be less than Rs. 9,46,419.00 estimate cost.
