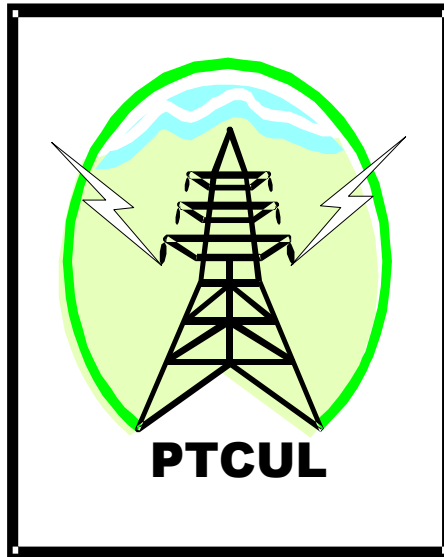

**PART A: GENERAL INSTRUCTIONS**

1. The prospective bidders are advised to visit [www.ptcul.org](http://www.ptcul.org) in advance and get themselves familiar with the procedures of registration and downloading of tender documents and all other statutory requirements of participating in web based tender.
2. This is a Single Stage Two Envelop System bid. The bidders are requested to read all the instructions/conditions of the bid documents & NIT carefully and submit their bid accordingly in two separate parts, each part in separate sealed covers, as per the instructions/procedures given in tender documents.
3. The cost of tender documents (Tender Fee), as mentioned above, is non-refundable and shall be paid in shape of Demand Draft of any Scheduled/Nationalized Bank only and shall be in favour of **Executive Engineer, 220 KV O&M Division, PTCUL, Haldwani** payable at **Haldwani**. No cash, cheque or postal orders shall not be accepted.
4. The Earnest Money shall be in shape of FDR/TDR only and duly pledged in favour of **Executive Engineer, 220 KV O&M Division, PTCUL, Haldwani**. No cash, cheque or postal orders shall not be accepted.
5. Any typographical mistakes in Tender Fee Demand Draft and Earnest Money FDR/TDR shall be deemed as disqualification of the bid.
6. The bidders have to quote their price only in Price Bid Format and in case the bidder is willing to offer any rebate or reduction in the price, the same should be clearly defined and mentioned in the Price Bid Format only.
7. Participation of Joint Venture Firms is not permitted.
8. The tenders shall be received and opened on the date as mentioned above or any extension thereof. In case the above date is declared a holiday, the tenders will be received & opened on the next working day.
9. The bids received after the due date and time of submission of bids, shall not be entertained. This office shall not be responsible for any kind of postal delay in submission of bids on or before requisite date and time.

**PART B: TECHNO-COMMERCIAL QUALIFYING REQUIREMENT**

1. The bidder should be a firm/contractor/service provider and the vehicle being offered for the services should be in the name of firm/contractor/service provider. In case the bidder is not the owner of the vehicle, submission of an undertaking for having been leased/rented on/partnered the vehicle legally for offering the services of vehicle to PTCUL is required
2. The bidder must have experience of having successfully completed similar or related nature works during last 7 years from the originally scheduled date of bid opening or have a running contract at present of similar nature. Submission of work completion certificate, clearly indicating the work completion date and executed amount of work, is mandatory for supporting the claim of work experience.
3. The bidder must have registration in Income Tax, GST and EPF and the relevant certificates are to be submitted mandatorily with the bid.
4. The vehicle being offered for services should be registered with RTO as taxi and should have valid Uttarakhand/All India Permit.
5. Submission of photocopies of Vehicle Registration, Insurance, Taxi Permit, and other documents related to vehicle for the said work is required with the submission of bid. If the bidder intends to offer brand new vehicle, submission of an undertaking mentioning that if selected as the lowest bidder, the bidder shall provide the requisite documents on the date of agreement, mandatorily.
6. The other details, terms & conditions are given in tender documents.

Undersigned reserves the right to reject the offer of one or all the bidders without assigning any reason thereof and no claim on this account shall be acceptable.
