QUALIFYING REQUIREMENTS

PRE-QUALIFYING REQUIREMENTS

Experience of having successfully completed similar works during last 5 years ending last day of month previous to the one in which applications are invited should be either of the following:

(a) Three similar completed works costing not less than the amount equal to Rs **1.95 Lakh**.

OR

(b) Two similar completed works costing not less than the amount equal to Rs **2.44 Lakh**.

OR

(c) One similar completed works costing not less than the amount equal to Rs **3.90 Lakh**.

TECHNICAL QUALIFYING CRITERIA (TQR)

1. The Tenderers /Bidders should have adequate experience of such type of work i.e. in Govt. Institutions'/CTU's/STU's or any other govt. department.
2. Experience certificates from the officer not below the rank of Executive Engineer or equivalent for having successfully executed the same or similar work mentioning nature of work, Agreement No., Amount of work, Scheduled time of completion of work and Actual time of completion etc.

FINANCIAL QUALIFYING CRITERIA (FQR)

1. Minimum Average Annual Turnover:- The minimum average annual turnover of the tenderer for the best three years(36months) out of the last five years should not be less **than Rs 7.31 Lacs**.
2. Access to Finance/Liquid Assets required should be **Rs 1.46 Lakh**.
- 3) Copy of PAN Card of Individual/Company/Firm/All partners in case of partnership firm should be attached.
- 4) The bidder must submit copy of GST Registration.
- 5) The bidder in joint venture/consortium shall not be considered.
- 6) The audited accounts of last five years i.e. balance sheet, P&L Account and other financial documents duly attested/certified by CA to substantiate fulfillment of PQR/FQR should be UDIN, failing which the tender will be summarily rejected without any further reference.
- 7) The bidder must submit Tender Fee in the manner as specified in tender documents/tender notice and submit its details. Offer without tender fee (in the manner as specified in tender documents/tender notice) shall not be considered under any circumstances.
- 8) The bidder must submit Earnest Money Deposit in the manner as specified in tender documents/tender notice and submit its details in the prescribed proforma along with copy of proof of such credit countersigned by tenderer.

Offer without EMD (in the manner as specified in tender documents/tender notice) shall not be considered under any circumstances.

9) Solvency Certificate: Latest Bank solvency certificate of 20% of the tender value is required to be furnished by the tenderer along with the technical bid.

10) Additional Documents

A part from various documents to be furnished along with the Bid as required in the tender document, the following documents/details (as applicable) are to be furnished by the Bidder:-
