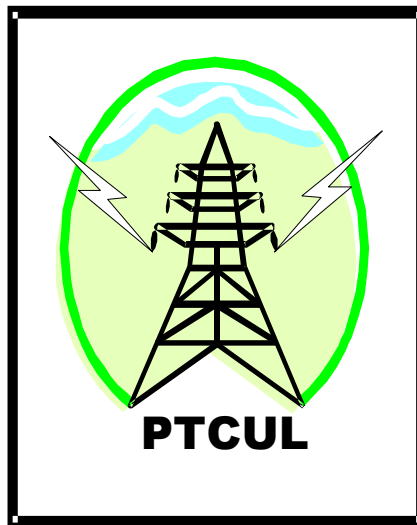

### **PART A: GENERAL INSTRUCTIONS**

1. The prospective bidders are advised to visit [www.ptcul.org](http://www.ptcul.org) in advance and get themselves familiar with the procedures of registration and downloading of tender documents and all other statutory requirements of participating in web based tender.
2. This is a Single Stage Two Envelop System bid. The bidders are requested to read all the instructions/conditions of the bid documents & NIT carefully and submit their bid accordingly in two separate parts, each part in separate sealed covers, as per the instructions/procedures given in tender documents.
3. The cost of tender documents (Tender Fee), as mentioned above, is non-refundable and shall be paid in shape of Demand Draft of any Scheduled/Nationalized Bank only and shall be in favour of **Executive Engineer, 220 KV O&M Division, PTCUL, Haldwani** payable at **Haldwani**. No cash, cheque or postal orders shall not be accepted.
4. The Earnest Money shall be in shape of FDR/TDR only and duly pledged in favour of **Executive Engineer, 220 KV O&M Division, PTCUL, Haldwani**. No cash, cheque or postal orders shall not be accepted.
5. Any typographical mistakes in Tender Fee Demand Draft and Earnest Money FDR/TDR shall be deemed as disqualification of the bid.
6. The bidders have to quote their price only in Price Bid Format and in case the bidder is willing to offer any rebate or reduction in the price, the same should be clearly defined and mentioned in the Price Bid Format only.
7. Participation of Joint Venture Firms is not permitted.
8. The tenders shall be received and opened on the date as mentioned above or any extension thereof. In case the above date is declared a holiday, the tenders will be received & opened on the next working day.
9. The bids received after the due date and time of submission of bids, shall not be entertained. This office shall not be responsible for any kind of postal delay in submission of bids on or before requisite date and time.

## **PART B: TECHNO-COMMERCIAL QUALIFYING REQUIREMENT**

1. The bidder should be an experienced and qualified firm/contractor and should have adequate exposure of manufacturing/execution of projects/supply of material involving the equipments of the type specified and has adequate technical knowledge and practical experience.
2. The bidder must have experience of having successfully completed similar works i.e. electrical maintenance works and supplies related to substations maintenance and transmission lines maintenance during last 7 years from the publication of the notice.
3. Submission of work completion certificate, clearly indicating the work completion date and executed amount of work, is mandatory for supporting the claim of work experience.
4. He has adequate financial capability and stability to meet the financial obligations arising out of the scope of works (the Bidder shall submit minimum three years of their Profit & Loss Account and Balance sheet).
5. The bidder must have registration in Income Tax, GST and EPF and the relevant certificates are to be submitted mandatorily with the bid.
6. The other details, terms & conditions are given in tender documents.
