- 1 The project (with all its stages) shall be completed within 01 year from the date of start which will be the date of issue of Letter of Award. And The bidder will provide support for 01 year from the Date of issue of Letter of Award.
- 2 The EMD can be submitted in the form of Bank Demand Draft/BG/FDR in favors of **General Manager (Project), office PTCUL, Dehradun** payable at Dehradun from any Scheduled Bank /nationalized Bank.
- 3 The prospective bidders are advised to obtain their user ID, Password, Company ID from website www.uktenders.gov.in for registration on the e-tender website.
- 4 The bidder can freely view and download the e-tender document from the website www.uktenders.gov.in and submit the bid on or before the date as mentioned in column No. 6 of above table. The tender fee shall be as mentioned above in the shape of DEMAND DRAFT of any scheduled bank payable at Dehradun in favour of " **General Manager (Project), office PTCUL, Dehradun**" which must reach **Executive Engineer PHQPU), PTCUL, Vidyut Bhawan, Near ISBT crossing, Majra, Saharanpur Road, Dehradun** along with EMD and Schedule-C in separate envelope on or before the closing date & time of submission & opening of Part-I (technical bid). - 8 It is mandatory for the bidder to submit the hard copy of **Schedule-C** (Bid validity declaration) and **‘Declaration’** regarding correctness of the documents, in Rs.100 stamp duly notarized,

A. Qualifying Criteria

Technical Experience

- 1) Bidder should be a Limited/Pvt. Limited/Sole Proprietorship company/ Partnership firm/Company registered under Companies Act 1956 and amendments /GST /any other applicable law/regulation in force in India. The Bidder must have the authorization certificate for Google Email Services.

- 2) The Bidder should not be blacklisted by any Govt. / PSU organizations in India.
- 3) The bidder should have experience of having successfully completed works during the last 07 years ending last day of the month previous to one in which application is invited.
Three similar completed works costing not less than the amount Rs. 10.60 Lakh each.
OR
Two similar completed works costing not less than the amount Rs. 13.25 Lakh each.
OR
one similar completed works costing not less than the amount Rs. 21.19 Lakh each.
- 4) Bidder must provide the details of Authorized signatory for signing the tender documents/bids.
- 5) The bidder shall have qualified technical personnel with experience in forest clearance, land demarcation, DGPS/Total Station survey, and transmission line route survey. Documentary proof of technical manpower shall be submitted with the bid.
- 6) The bidder shall have successfully completed at least one similar work of forest clearance and/or land demarcation/survey for 132 kV or above transmission lines, substations, or other infrastructure projects for any Central/State Government, PSU, or Autonomous Body during the last seven (07) years. Copies of work orders and completion/ performance certificates shall be submitted with the bid.

Financial Qualifying Requirement

1. Bidder should have a cumulative Minimum average annual turnover for the bidder for the best three (03) years out of last Four (05) years should not be less than Rs. 39.74 Lac.
2. The bidder must demonstrate availability of access to finance for Rs. 7.95 Lac at the time of bidding.
The Bidder should have all applicable Registration certificates viz., Company Registration certificates including GST, PAN card, EPF registration certificate

B. E.P.F. Registration certificate is mandatory to be submitted with the technical bid (part-I).
