PRE-QUALIFYING CRITERIA

Technical Qualifying Requirement

1. The bidder should be a firm/contractor must have an experience of successfully completed the **“Electrical nature work in 132KV and above Sub-Station satisfactorily in GOU/GOI/PSU/ Central & other State Government”**. The above work should have been completed during last 07 years from the originally scheduled date of bid opening. Submission of work completion certificate, clearly indicating the work completion date and executed amount of work, is mandatory for supporting the claim of work experience.
2. Uttarakhand State Valid Electrical Inspector Registration of ‘A’ Class and validity of the registration should be furnished along with the technical bid.
3. Experience of having successfully completed similar works as mentioned above during last 07 years from the originally scheduled date of bid opening should be either of the following:-
Three similar completed works costing not less than **Rs. 0.94 Lac (Rupees Ninety Four Thousand Only) each.**

OR

Two similar completed works costing not less than **Rs. 1.17 Lac (Rupees One Lakh Seventeen Thousand Only) each.**

OR

One similar completed works costing not less than **Rs. 1.87 Lac (Rupees One Lakh Eighty Seven Thousand Only).**

Financial Qualifying Requirement

1. **Minimum Average Annual Turnover:** The minimum average annual turnover of the tenderers **for the best three years (36 months) out of the last five years (60 months) should not be less than Rs. 3.51 Lakh (Rupees Three Lakh Fifty One Thousand Only).** The bidder must submit Audit Accounts (P&L A/c, Balance sheet etc.). The balance sheet and all other financial documents attested/certified by Chartered Accountants to substantiate fulfillment of FQR should be within UDIN failing which the tender will be summarily rejected without any further reference.
2. The other details, terms & conditions are given in tender documents. Undersigned reserves the right to reject the offer of one or all the tenderers without assigning the reason thereof and no claim on this account shall be acceptable. All other details and terms & conditions are available in tender documents.
3. Registration in Income Tax, GST, EPF, ESI & RTGS, NEFT Details are mandatory and the relevant certificates are to be submitted with the Technical Bid (Part-I) to qualify the **FQR**.
4. **Joint Venture Firm:-** In case of Joint Venture, the following condition shall also apply:-
 - (a) Joint Venture (JV) will be allowed for a maximum of two firms only.
 - (b) One of the partners shall be nominated as lead/authorized partner in the JV deed/agreement.
 - (c) The lead/authorized partner shall receive instructions/communication and sign tender/contract document for and on behalf of both partners of the Joint Venture.
 - (d) The billing/invoicing shall be raised by the lead/authorized partner and all the statutory deductions/compliances shall be made as per information mentioned in the submitted bills/invoices, accordingly.
 - (e) Payment shall be made to the lead/authorized partner's account or in the Joint account of partners as authorized by the JV at the time of submission of bid.
 - (f) The Joint Venture shall be solely responsible for all the legal and statutory compliances and PTCUL shall not be responsible in case of any default in the said matters.
 - (g) Both partners of the Joint Venture shall be liable jointly and severally for the execution of the Contract in accordance with the contract terms and a statement to this effect shall be included in the Bid Form and in the Contract Form (in case of successful Bid).
 - (h) Any dispute that may arise between PTCUL and the Joint Venture during or after execution of the contract, shall require the explicit Consent in writing of both partners in case of alternate dispute resolution mechanism or the cases before any judicial authorities and these authorizations shall be evidenced by submitting a Power of Attorney signed by legally authorized signatories of both the partners.
 - (i) Agreement entered into by the joint venture partners shall be submitted with the bid and will remain in force during the tenancy of contract, Guarantee Period thereafter and till the time the contract is finally closed.
 - (j) Any partner shall solely or JV jointly shall meet Technically Qualifying Requirement (TQR) of the respective tender.
 - (k) The Bank Guarantees such as Earnest Money Deposit/Performance Bank Guarantee/Mobilization Advance Bank Guarantee shall be submitted by any of the Joint Venture partner.
